

### NOTICE TO BOARD FOR OWNER UNIT CONSTRUCTION, ALTERATION OR IMPROVEMENT

For owners undertaking any construction, renovation or repairs the following process should be followed to ensure that all required permitting is obtained and that the association is aware of any upcoming construction projects.

Important: The Castaway Cove Board of Directors and our Management Company are not involved or responsible for permitting of any construction or renovation activities by owners. Completing this form ensures the board is aware of any construction projects, that the owners are aware of their permitting obligations, and that your neighbors are aware of any upcoming construction projects. The process to be followed is:

- The Castaway Cove Board of Directors and the Castaway Cove Condominium Association do not become involved in any required permitting. The unit owner is responsible for all permitting and inspections.
- The unit owner completes form: **NOTICE TO BOARD FOR OWNER UNIT CONSTRUCTION**, **ALTERATION OR IMPROVEMENT**.
- Prior to the start of a project, unit owner should obtain any permits required by the city, state or county.

Contractors are required to follow Castaway Cove Construction Procedures as found in the Castaway Cove Rules and Regulations (CCCA-007). Under these rules, contractors / homeowners are responsible for daily cleanup of walkways, stairs and common areas. Construction is only permitted between 8 AM and 5 PM, Monday – Saturday. Unit owner are requested to provide 24-hour courtesy call to the Board of Directors to schedule roof access.

Due to COVID-19, until further notice all workers must wear masks in common areas including but not limited to the lobby, elevator and walkways.
